*Mode of Appointment:* Regular/Contract/Deputation

Good candidates may be considered for Regular position. Applicants interested to be considered on deputation may also apply.

*Qualification:* MBBS from a recognized University in India or abroad. Consistently good academic record is required. Lieutenant Colonel/Colonel/equal from Navy & IAF having served in Army Medical Corps /equal are encouraged to apply.

*Experience:* Minimum 10 years (8 years for SC/ST) of relevant post-qualification experience (excluding apprenticeship or training period) in a government department or public sector/autonomous academic/research institution/commercial organization of national/international repute, with at least 3 years in the immediate lower pay level 11 (7<sup>th</sup> CPC) or (pre-revised scale of Grade Pay of Rs.6600/- in the Pay Band of Rs.15600-39100 or in higher scale). Good communication skill in English is essential. If working in private sector drawing salary should be Rs. 90,000- 95,000 per month.

*Age:* Not exceeding 50 years (55 years for SC/ST) as on the last date for receiving application. In the case of candidates on deputation age can be upto 55 years (including SC/ST). For appointment on contract age not exceeding 65 years.

*Functions:* Chief Welfare Officer will be the In-charge of welfare activities, general administration and effective functioning of student's health and wellness activities of the Institute.

2. Shortlisted applicants are required to mandatorily bring the filled application in the prescribed Format along with documents, sent through email on the day of selection process.
3. Applicants are advised to satisfy themselves before applying that they possess at least the minimum essential qualification and experience laid down for the post.
4. Above position require a near 24x7 commitment to the Institute. Therefore, candidates willing to dedicate themselves fully to the Institute are expected to apply.
5. Appropriate functional title may be assigned to the selected candidates at the positions advertised.
6. Those who are in regular service in government/public sector establishments may be required to produce a *No Objection Certificate*, if called for selection process.
7. The SC/ST candidates are required to attach the Caste certificate in the format prescribed by Government of India and issued by competent authority.
8. Age relaxation for SC/ST/OBC/ Persons with Disabilities (PWD) and Ex- Serviceman candidates will be applicable as per Government of India norms.

Applicants having at least 3 years’ experience in a similar or immediate next lower position in any of the IIMs may be given two years relaxation and applicants having at least 2 years’ experience in a similar or immediate next lower position in any of the IIMs may be given one year relaxation in required work experience.
11. Mere fulfilling of the minimum qualifications/eligibility criteria and experience will not confer any right to the candidates for being called for selection process.
